ZTL PERMIT FOR TOURIST BUSES

2. VALIDITY

The rates indicated in the summary table (with reference to points 1-2-3-5) are valid until midnight on day for which the permit was purchased.

The sole exception of that is reserved for tourist buses directed to the "Accommodation facilities of the municipalities of Cavallino Treporti and Jesolo" (point 4), whose validity expires at 12.00 of the day following the one for which it was purchased, or in any case until 12.00 of the last day, in case of multi-day purchase.

There is a flat rate of € 380.00 (€ 360.00 in the case of online purchases) recognized exclusively for tourist buses directed to the accommodation facilities of Cavallino-Treporti and Jesolo, for purchases made for the same bus (license plate number) to be used on more than 4 consecutive days, seamlessly.

3.1 PURCHASE METHODS - Online Purchase

The service is active on the website www.ctservizi.eu (ZTL section - Online Purchase) with advance payment via credit card.

In order to guarantee greater protection for online purchases, and prevent any use for illicit activities, it is essential to register the card you intend to use with the bank (or credit card issuer).

To purchase the ZTL permit, it is necessary:

- Accredited yourself on the <https://ecommerce.ctservizi.eu/> , generating your own password and an Username code;
- Send an email to ztl@ctservizi.eu with an attached copy of the registration document of one or more buses, which will be registered by our operators in the general database;
- After receiving confirmation from the ZTL office that the vehicle has been registered, proceed with online order, following the steps required by the program.

To purchase the transit document, the buyer have to submit the required attachments, depending on the type of permit chosen. In particular, please note that the system will request the following attachments:

-ACCOMMODATION FACILITIES Rate: document confirming the reservation of the stay issued from the accommodation facility to which the bus is headed;

Only for this type of permit, the validity ends at 12.00 on the day subsequent to the one for which it was purchased. Therefore the date to indicate is the day following the validity date.

Example: Pass valid for day 1 must indicate day 2 at 12.00 as the exit date.

- SCHOOL TRIP fee: letter of introduction from the school, on headed paper with stamp and signature of the school manager;

-ATYPICAL SERVICE OR COMMERCIAL LINE SERVICE Rate: copy of authorization pursuant to Regional Law 46/1994 or the commercial line service.

Incompletely formulated purchase requests will not be accepted.

The request and payment of the pass must take place at least 36 hours before its validity date.

The pass will be available for printing after appropriate checks by the ZTL office. Only in case of purchase of permit for "Ordinary Tourist Bus", the pass will be available to the user in the specific area of the website www.ctservizi.eu (ZTL section - Online purchase), together with the receipt of the payment confirmation email.

The date, arrival time and type indicated in the purchase request cannot be changed by the staff.

CT Servizi Surl declines all responsibility for any type of inconvenience resulting from any system malfunctions or for any errors in completing the request.

3.2 PURCHASE METHODS – Purchase at the Cavallino ZTL Check Point

All types of passes can be purchased at:

Check Point ZTL, temporarily open at the CENTRO CULTURALE PASCOLI, in via Equilio 2 (entrance from the via Fausta side). The office is open every day. On public holidays the counter is open with reduced hours.

Please, consult the timetables on the website www.ctservizi.eu .

ATTENTION: from May 1st to September 30th, every Tuesday, market day, the Check Point is open in Punta Sabbioni location, in Via Fausta 12, in front of the ACI car park.

4. Refunds

Under no circumstances can the pass purchased at the counter or printed online be refunded.

5. Usage

The period of validity is shown on the pass.

Failure to use it during its validity period will result in the forfeiture of any rights. The pass must be displayed clearly visible on the windscreen of the bus (Police Ordinance no. 1 of 16/01/2008)

6. Invoice

The sale of permits does not entail the issuing of an invoice (EXEMPTION FROM STAMP DUTY art.5 tab. annex B annexed to Presidential Decree 642/1972).

On the printed permit, in the bottom line, a tax receipt appears, valid in accordance with the law.

The data will be processed in accordance with EU Regulation 2016/679, and with Legislative Decree 196/03 and subsequent amendments.
